The federal law enforcement agencies, including the DEA, the FBI, and the agencies of the Department of Homeland Security, initiate tens of thousands of administrative forfeiture cases every year, and federal prosecutors file civil and criminal forfeiture actions in federal courts in thousands of cases as well. Overall, in each of the last few fiscal years, the Government has confiscated over three-quarters of a billion dollars in criminally-derived property. This law enforcement activity has naturally generated a deluge of case law from the federal courts. New forfeiture cases are decided every week, making it difficult for the courts themselves, as well as practitioners, to keep current. Moreover, Congress is constantly amending the forfeiture laws and enacting new ones including a set of new forfeiture provisions included in the USA Patriot Improvement and Reauthorization Act signed by the President in March 2006. Finally, in response to the explosion in forfeiture litigation, the Supreme Court has issued a new Supplemental Rule G of the Federal Rules of Civil Procedure dealing exclusively with civil forfeiture that took effect on December 1, 2006.
